Legal Suit/Proceedings:

**DOMHCV 54 of 2018 – Ian Dorival v NBD & Chairman of the Board of Directors, Anthony John**

Summary of the Facts:

The Claimant and Mr. Grayson Stedman were elected to the board of directors of the 1st Defendant (*'the Board'*) at the annual general meeting held on the 24th day of March, 2017.

The Human Resource and Corporate Governance Committee of the Board (*'the Committee'*) conducted an inquiry into the Claimant's eligibility to remain as director of the 1<sup>st</sup> Defendant, based on the information which was provided by Mr. Dorival.

The Committee determined to recommend to the Board that the Claimant was not eligible to serve as a director of the 1<sup>st</sup> Defendant, as he did not meet the fit and proper person criteria (*'the Fitness Criteria'*).

At a meeting of the Board of Directors held on the 10<sup>th</sup> day of May, 2017, the Board acknowledged that the Claimant was in a long standing romantic relationship with NBD's Executive Manager of Banking Services, Ms. Nellisa Anselm who is responsible for the core function of the Bank. The Board recognized there is a high level of co-operation and interaction between the Board and Executive Management and its oversight responsibility of the senior management team. The Board recognized this is a pervasive and material conflict of interest between his personal circumstance and duties as a director. The Board felt that this impugned the Claimant's competence, ability and soundness of judgement in fulfilling his responsibilities as a director of NBD Ltd and decided that the Claimant did not satisfy the Fitness Criteria and therefore cannot be a director of the Bank.

The Claimant, Mr. Dorival, avers that the said actions of the Committee and the Board were illegal or otherwise unauthorized by law.

Mr. Dorival claims amongst other things, damages inclusive of exemplary and aggravated damages for wrongful termination of his position as director; damages inclusive of exemplary and aggravated damages for defamation by innuendo and/or reputational injury; damages for libel and costs.

The parties appeared in a trial of the matter before the High Court Judge on the 28<sup>th</sup>, 29<sup>th</sup> and 30<sup>th</sup> days of May, 2018. Submissions are due to be filed by legal counsel for the parties by Wednesday, June 06, 2018. Subsequent thereto, the parties will await the decision of the Court.
