

Grenreal Property Corporation Limited (the " Company ") was specifically set up to enable private, professional and institutional investors to benefit from the successful development of the cruise tourism industry in Grenada, in particular, and the development of Grenada as a tourist destination in general. Grenreal also provides a prime commercial spaces for the conduct of leisure and professional services locally.

The company has been in operation for over sixteen years. It offers business opportunities to positively enhance regional commerce and influence cruise tourism in Grenada. It is the owner of property located on the reclaimed land situated at the St. George's Cruise Port, the " Esplanade Mall " and the " Dr. Jan Bosch Building " more commonly known as the Bruce Street Commercial Complex.

The properties are rented to third parties and have very low vacancies. The combined value of the two buildings to date is approximately EC\$66 million. The company's equity value is approximately EC\$37 million and it is presently owned by private as well as public entities. The Company's shares were listed at the Eastern Caribbean Securities Exchange in St. Kitts and Nevis in July 2008.

In 2021, the grenadian economy started to show positive growth despite the ongoing Covid-19 pandemic. Throughout 2021, Grenreal's overarching goal continued to be maintain liquidity and honour its obligations.

During the Financial year 2021, The company was able to accomplish the following:

1. Secure an extension of the moratorium on it's Syndicate Bond payments from its financiers.
2. Provided various levels of discounts to tenants in order to maintain the occupancy level during the continuing covid-19 pandemic.
3. Implemented cost cutting measures to reduce expenditure.
4. Worked towards maintaining the occupancy level in the Bruce Street and Esplanade Malls despite the slowdown in economic activities.
5. Worked toward creating an inviting shopping environment for visitors.

<p>Risk factors that may impact on Grenreal's operations:</p> <p>Nature of the real estate industry:</p> <p>There are existing shopping malls in Grenada that can be viewed as competitors of Grenreal. In terms of pricing they can have lower rates. However, Grenreal as the sole cruise passenger mall on the island retains a competitive edge.</p> <p>Dependency on economic conditions:</p> <p>Limited economic activity has an adverse impact on revenue collections. During the year 2021 Grenada experience macroeconomic growth of 5.32% a opposed the contraction 13.76% due to the Covid 19 pandemic in 2020(Macrotrends). It was expected that there will be a consistent increase in economic activity once covid-19 infections are controlled, cruise ships cruises return to the island and St. George's University is reopened. growth will stand at 3.3% in December 2022(Grenada Parliment Mid Year Review). The end of the Covid -19 pandemic was anticipated at the end of 2022. Continued growth will positively affect Grenreal's business.</p> <p>Development of the tourism industry</p> <p>The Grenada Tourism Authority (GTA) continues to to monitor the global tourism market as the world reacts to the spread of the global Covid 19 pandemic. Cruise liners are expected to return to their regular destinations as cruise bookings for the 2021-2022 season continue to increase. It is also expected that consumer confidence in airline travel will return in the short term. However, if the source markets continue to struggle with controlling the spread of the virus, the tourism industry will be adversely affected. The GTA is working to keep all stakeholders engaged in discussion on the way forward inspite of the uncertainty. Great effort is being exerted on the implementation of protocols for reopening the tourism sector.</p> <p>Liquidity risk</p> <p>Grenreal can face difficulty in meeting its financial obligations in particular loan payments. The company, as far as possible continues to mitigate same by ensuring sufficient resources are available when due, under both stressed and normal conditions. As part of receivables management tenants are actively engaged to comply with lease terms and conditions, and are granted discounts.</p> <p>Changes in legislations</p> <p>Grenreal is generally affected by changes in government legislation. Legislation- Emergency Powers Regulations implemented as a result of the Covid 19 pandemic on March 25th, 2020 adversely affected economic activity in the mall. The slow but continuous easing of restrictions may assist with the re-growth of the economy.</p> <p>Operational risks</p> <p>The possibility of deficiencies in company information and control systems, human error and disasters are assessed regularly and measures are implemented to reduce same. In particular, continuous upgrades to systems, supervisory control to minimize human error, insurance coverage for natural disasters and other policies where applicable.</p>

General Discussion and Analysis of Financial Condition

Total Income for the year ended December 31st, 2021 was EC\$2,247,893, (year ended December 31st 2020: EC\$2,994,886) a 24% decrease. This decrease in income is primarily the result of the further increase in % discounts offered to cruise oriented tenants. These tenants received a further 25% discount on their contracted rent. Several tenants expressed their gratitude as, in their words, they would not have been able to survive the depressed economic conditions of 2021 without the discounts..

Despite the negative impact of the Covid-19 pandemic on the Grenadian economy and by extension the businesses of the tenants, the demand for rental spaces in the malls has grown. However, during the year 2021, Grenreal's occupancy rate reached 100%. Grenreal is encouraged by the number of continuing inquiries for rental space. It is believed that should any retail unit be vacated in the near future, the unit will be easily rented.

During the year 2021, Grenreal was able to maintain a cash balance that allowed for some ease of operations despite the discounts offered. Grenreal avoided a possible liquidity crisis through the gracious acquiescence of the Syndicate Bond Holders to a request from Grenreal for a moratorium on principal and interest.

Grenreal's property was valued at EC\$66,325,800 as at 31st December 2021 compared to a valuation of EC\$48,078,600 at the end of the previous year. The Income Method was used to arrive at the Market Value of the property. The valuation was done by an independent valuator.

Grenreal's total assets increased by \$18,271,586, this is also primarily as a result of the improvement in property valuation.

Cruise ships returned to the island at the end of 2021. This gave a much needed boost to the businesses within the mall. At the end of 2021, it was also decided that the discounts afforded to Grenreal's tenants because of the covid-19 pandemic would be discontinued.

Discussion of Liquidity and Capital Resources

As of December 31st, 2021 the company's working capital ratio(current assets : current liabilities) is 0.23:1. At the end of December 31st, 2019 this ratio was higher at 0.41:1. This means that there is 23 cents of current assets available to cover every dollar of current liabilities. An invoice for legal services in the amount of \$351,014.00 was recognised in December 2020, thus the weakening of the working capital ratio. As the legal bill is paid down and arrangements made to settle the interest accrued on the moratorium, this ratio is expected to improve.

Tenants generally attempted to make timely payments on their rents. The tenants that mainly cater to cruise passengers collectively requested further relief during 2021. In response to their request, management granted a further 25% discount to the most affected tenants. Receivables as at year end 2021 was approximately \$329,072 as of December 2020 the receivables balance was\$294,072. It should be noted that significant write off were applied to a few tenants during 2020.

The company's debt to equity ratio at the end of 2021 is 0.61:1 (December 2020- the ratio was 1.07:1. There is \$1.07 of long term debt to every dollar of equity. This ratio has improved to pre pandemic levels as the positive outlook for the year 2022 influenced an increase in the property valuation.

Overview of Results of Operations

Retail tenants generally received discounts of 50% whereas cruise oriented tenants generally benefited from 75% discounts. Total Income for the year ended December 31st 2021 was EC\$2,247,893, (year ended December 31st 2020: EC\$2,994,886) a 25% decrease. This decrease in income is the result of depressed economic activity due to lock downs and limited movement imposed by Grenada's government to curb the spread of covid-19.

Grenreal's management continuously strive to reduce the vacancy rates within the Malls, During the year 2021, 100% occupancy was achieved. New space was created within the mall to accommodate the new sports bar and the salad/ soup bar. Grenreal also anticipated the opening of a popular ice cream chain within the mall.

Operational expenses for the year ended December 31st 2020 was EC\$1,529,551 (year ended December 31st 2020: EC\$1,593,806), a decrease of 4%. The main source of the decrease in operational expenditure is a 13% decrease in security expenses and public relations. Notwithstanding these decreases, there were cumulative increases in Janitorial expenses (sanitising supplies), maintenance and utilities.

General expenses for the year ended December 31st 2021 changed by \$9,015 or a 3% decrease to EC\$287,957 (year ended December 31st 2020: EC\$296,972). Included in general expenses, was a decrease of \$17,286.00 in legal fees. These fees were incurred for work done in preparation for the extraordinary shareholder's meeting on January 8th, 2020, held to convert shareholders loans to preference shares.

It must be noted that for the year 2021 Grenreal generated operating profits of \$365,053.
